Competitors: The Championship is confined to competitors from the year in which they

reach their 18th birthday (Jumping) and 16th birthday (Dressage)

Certificates of Capability:

Only competitors and horses qualified for the Championship may be entered. The deadline date for obtaining a certificate of capability in Jumping is 26th July 2009.

Dressage:

Only competitors and horses qualified for the Championship may be entered. The procedure for qualification as published by the FEI, must be strictly followed and can be found on the FEI website.

The deadline date for obtaining a certificate of capability in Dressage is 26th July 2009.

Jumping:

Only those competitors and horses likely to be able to complete the Championship may be entered. Information for NF's on completing Certificates of Capability can be found on the FEI website. The procedure for qualification, laid down under Annex VIII of the present rules, must be strictly followed. Upon arrival at the Championship, Chefs d'Equipe can exchange competitors and horses at will, whether originally qualified as combinations or not. After the first championship competition, no further changes are permitted.

Confirmation of receipt of a Certificate of Capability will be done over the FEI website.

6. ENTRIES (Art. 121, 251, 319)

All riders & horses participating in any International competition must be registered with the FEI.

Entries in Principle: Monday 2nd February 2009

Each NF must declare whether they intend to participate with a team or with individual competitors.

Nominated Entries: Monday 27 July 2009

Each NF may enter a maximum of 8 competitors and 16 horses (Dressage) and 10 competitors and 20 horses (Jumping). For all competitors and horses entered, a Certificate of Capability must be confirmed on the FEI website. The name and address of the team veterinarian has to be included with the entries.

Entry forms must include the following information on horses:

Name of horse, date of birth, breed, country of birth, stud-book initials, FEI passport number, name(s) of owner(s), colour, sex & qualifying results.

Entry forms must include the following information on competitors:

Name of competitor, FEI-ID (1000XXXX), date of birth, address, email, phone, qualifying results.

Definite Entries: Friday 14th August 2009

Each NF may enter a maximum of 4 competitors and 4 horses or up to 2 individual competitors with 1 horse each (Dressage) and a maximum of 5 competitors and 5 horses or up to 2 individual competitors with 1 horse each (Jumping). All competitors and horses must be chosen from the list of nominated entries.

All entries must be submitted using the HippoBase online entry system. The OC and the FEI will regard the data supplied online as the only official entry information. Any information sent to the OC by email or fax, which could also be entered directly into the online system, will not be accepted. The FEI will approve participation (certificates of capability) based on qualifying results entered into the system.

All competitors have to be entered by their home NF.

N.B. If any competitor withdraws after the date of definite entries without a valid reason (i.e. illness or lameness), the competitor will be held liable to reimburse the OC for the actual financial loss suffered by the OC (i.e. limited to stabling and hotel expenses) as a result of the late withdrawal.

2. GROOMS

4. HORSES

a) Championship competitors, incl. the 5th rider:

Horses will be stabled free of charge in boxes (4m x 3 m) on the show grounds. The Championship stables will be open from noon on Saturday 22nd August to Noon on Monday 31st August, 2009.

Bedding (wood shavings) – reasonable quantities will be made available free of charge by the OC. Additional supplies will be available for purchase from the Fodder Store throughout the event.

Any rider requiring straw should order this in advance through the Hippobase Entry System.

Hard Feed and Fodder will be the responsibility of the individual competitor although supplies of Horsehage[™] and a limited selection of hard feeds will be available for purchase. Orders for hard feed should be made from the Fodder Store prior to 4.00 pm on any day for delivery by 8.00 am the following morning.

Electrical supply for caravans and live-in-lorries will be made available at a cost of £ 50.00 (incl. VAT) (€ 65.00) and must be ordered through the Hippobase Entry System.

The OC will grant reimbursement of transport charges from the UK border or place of arrival in the UK to Windsor per vehicle carrying horses as follows:

5. WELCOME

The time and date of arrival of riders and horses and their means of transport must be given to the OC in order to assist them on arrival.

6. LOCAL TRANSPORTATION - ARRANGEMENTS FROM HOTEL TO SHOWGROUNDS

Courtesy transport will be provided between the Official Championship Hotels accommodating riders, chefs d'equipe, team veterinarians & officials and the showground. Collection and return of riders, chefs d'equipe, team veterinarians & officials to/from London Heathrow Airport and local Railway Stations will also be possible subject to the the organiser's being informed of such requirements by those concerned.

7. ADVERTISING AND PUBLICITY ON COMPETITORS AND HORSES

The competitors are authorised to carry the logo of their personal sponsor on the saddle cloth in accordance with Art. 136.1-2, except in the team competitions, in which only the national emblem and the sponsor logo of the national team are permitted. The Chief Steward will check that the advertising and publicity on competitors and horses complies with Article 136 of the General Regulations.

8. SCORING - OPEN SCORING (Dressage)

An open scoring system shown on digital screen for Grand Prix.

Note: Scores per judge may not be shown on screen that is visible to riders and judges in the arena. If visible, running score and score to beat should be shown.

The Organising Committee will inform its national veterinary authority and its customs authority at least four weeks prior to the event. 2. HEALTH REQUIREMENTS FOR THE ENTRY OF HORSES

All horses imported on a temporary basis must be in possession of the following documents:

EC Competitors

It is strongly advised that Peden Bloodstock Ltd be contacted at least **10 days** prior to the competitors arrival with horses of European Community (EC) origin. Each horse must be accompanied by the current Intra-Community health certificate and its FEI Passport completed.

Non-EC Competitors

It is strongly advised that Peden Bloodstock Ltd be contacted at least **three weeks** prior to the arrival with horses from outside the European Community. Each horse arriving in England from a non-EC country must be accompanied by the correct health certificate for import into the EC and its FEI Passport fully completed; Peden Bloodstock Ltd will provide details of the health requirements and the appropriate certification on request.

Horses and equipment from outside the EC must be accompanied by an ATA Carnet issued in the country of origin; these are obtainable from local Chambers of Commerce and/or Peden Bloodstock Ltd will provide details on request. Either the National Federation or the competitor concerned will be held responsible for any costs in connection with temporary import into the EC for those animals or equipment not accompanied by an ATA Carnet.

Certificates must be completed in at least one official language of the country of destination and in one official language of the member country. The competitor must carry with him the original certificate, not a copy.

British Export Welfare Regulations

Under British law, Export Licences are required for every horse or pony leaving the country, any animal without one can be detained at the port of export and the driver could be prosecuted; the Licences are issued by the Ministry of Agriculture and Peden Bloodstock Ltd will obtain them for each animal, providing the essential information is supplied by each competitor at least **ten days** prior to the start of the Championship

VETERINARY REGULATIONS, 11th Edition, effective 1st January 2009
(see website www.fei.org)

VETERINARY EXAMINATIONS, HORSE INSPECTIONS & PASSPORT CONTROLS

These will be carried out in accordance with the "Veterinary Regulations", Art. 1011 & the discipline rules.

"General Regulations", 23rd edition, effective 1st January 2009 will apply: Art. 139.1

Every horse entered for any competition at CNs or ClMs (see Appendix D) in a foreign country (see GRs 141.2), and all horses entered for other Cls, ClOs, Championships, Regional and Olympic Games, whether at home or in foreign countries (see GRs 141.2), must have an official, valid FEI Passport, or a National Passport approved by the FEI and accompanied by an FEI Recognition Card and, when applicable, an FEI registration number, as a means of identification and to establish ownership.

Art. 139.2

Horses taking part in CNs and CIMs (see Appendix D) in their country of residence are not required to have such a passport as is mentioned in paragraph 1. All such horses must be properly registered and identifiable and, unless there is no national requirement for equine influenza vaccination in the host country and in the country of origin all horses must have a valid vaccination certificate.

EQUINE INFLUENZA VACCINATION, VET. REGS. ANNEX VII (except events taking place in NZL & AUS) From 1 January 2005 onwards, influenza vaccination for all horses competing in FEI competitions requires a vaccination within six months + 21 days of the competition.

- 1. All horses intending to participate in FEI competition must have at least received an initial primary course of two vaccinations, given between 21 and 92 days apart. Thereafter, a third dose (referred to as the first booster) must be given within 6 months + 21 days after the date of administration of the second primary dose, with at least annual boosters given subsequently (i.e. within one year of the last dose).
- 2. If the horse is scheduled to take part in an FEI competition, the last booster must have been given within 6 months + 21 days of arrival at the FEI event. (The 21-day window has been provided to enable vaccination requirements to fit in with the competition schedule).
- 3. No vaccination shall be given within 7 days of the day of arrival at the FEI event.

4. All horses that were certified as correctly vaccinated under the previous FEI equine influenza vaccination rule prior to 1st January 2005, do not need to start a primary course again provided that they have complied with the previous rule of primary course and annual re-vaccinations and the new rule of a booster vaccination within 6 months + 21 days of the day of arrival at the FEI event.

SAMPLING FOR PROHIBITED SUBSTANCES (Vet. Regs. Chapter V & VI and Annex IV)

Regular sampling is carried out in CCI3* and CCI4*, CSIs (3*, 4*, 5*), CIOs, World Cup Qualifiers and Cup Finals, Championships and Games, whereas at other CIs sampling is recommended. Where testing takes place, the number of horses tested is at the discretion of the Testing Veterinarian/Veterinary Delegate. At CCI3* and CCI4*, CSIs (3*, 4*, 5*), CIOs, World Cup Qualifiers and Cup Finals, Championships and Games it is recommended that a minimum of 5% of all horses (with a minimum of 3 horses tested) must be sampled (see also VR Art. 1016.6.).

Special guidelines are applicable for events covered by the FEI Medication Control Programme (Groups I & II only).

MEDICATION CONTROL PROGRAMME (GROUP I & II ONLY)

The Organising Committees of FEI events within Groups I & II are advised to charge competitors the equivalent of CHF 12.50 per horse per event as a contribution towards the costs of the MCP programme.

VETERINARY ASPECTS "B" A) CUSTOMS FORMALITIES

NFs holding an international event in their country should inform their National Veterinary Authority and their Customs Authority at least four weeks beforehand. They should request every facility to assist the movement of horses accompanied by FEI Passports, and the necessary veterinary certification at frontier crossing points into and out of their countries. (Vet. Regs. Art. 1004.2)

B) MCP CENTRAL LABORATORY - APPLICABLE ONLY TO GROUPS I & II

Under the Medication Control Programme (MCP) in Groups I and II, all samples collected in accordance with Vet. Regs Art. 1016 will be analysed by the **Laboratoire des Courses Hippiques (LCH), 15, rue de Paradis, F-91370 Verrières le Buisson**. The central MCP
Laboratory will be reviewed in June 2009. Please refer to FEI Bulletin for further information. For events other than those listed in Vet. Regs Art. 1016 or for events other than in Groups I and II, samples may be analysed at an alternative FEI listed laboratory (Vet Regs Art. 1021).

VII. MISCELLANEOUS

1. OBJECTIONS/COMPLAINTS (Art. 163 – 166)

OBJECTIONS. In all international competitions objections must be made in writing in accordance with Article 170 - 171 of the FEI General Regulations and accompanied by a deposit of € 100.00 (150CHF) in cash. Exchange Rate at 1.6 valid as of the date of the signed off schedule. The declaration upon any decision of the Appeal Committee who determine the Objection shall be final and binding and the Objector shall, by lodging the objection, be taken to agree that such a decision shall be final and binding upon him, and that no appeal there from shall lie upon any ground whatever. If the objection shall be determined against the Objector he shall also be liable to the event for the amount of costs and expenses occasioned by the objection and the determination thereof, unless in the opinion of the Appeal Committee who

determined the objection there existed good and reasonable ground for the objection when they may order to the contrary.

2. GENERAL CLASSIFICATION AT THE END OF COMPETITIONS.

Classification will be according to the FEI Rules for Dressage Events (Art. 451) and the FEI Rules for Jumping Championships and Olympic Games (Art. 328) relevant to each competition of each discipline.

In the discipline of Dressage, FEI Medals will be awarded for the first three teams in the Team Championships and for the first three individuals in each of the two Individual Championships.

In the discipline of Jumping, prizes will be awarded for individual placings in each competition, allocation of which must follow the provisions of the FEI General Regulations. In addition, FEI Medals will be awarded to each member of the three best placed teams in the Team Championships and for the first, second and third placed individuals in the Individual Final.

3. PRIZE CLASSIFICATION - (Art. 126, 127, 128) N/A

4. PRIZE-GIVING CEREMONY

For Championship Classes - according to protocol as supplied by the FEI Directors of Dressage and Jumping.

At least, the eight highest placed riders in each competition will be required to present themselves for the prize-giving ceremony for that competition. This will be confirmed by the competitor information system during each competition. All Prize Winners to attend.

The owner of the winning horse will be invited to the prize giving ceremony for the Grand Prix.

5. DEDUCTIONS FROM PRIZE MONEY

All prize money and all/any prizes in kind rewarded instead of prize money as well as reimbursements (e.g. travelling expenses) will be distributed according to FEI General Regulations Art. 130.2. Settlement will be made per competitor.

The prize money won will be paid after deduction of any possible outstanding debts of the respective rider and/or his horses' owners at or in connection with the Championship.

Deductions from prize money including government taxes will be made in accordance with British/EU law. All participants will be provided with an official form showing details of these deductions. All prizes will be a subject to the 15 % tax according to the British law.

Those foreign competitors being exempted from tax deduction are kindly asked to submit an exemption certificate either with the entry or on the first show day at the latest. Every competitor himself is responsible for the correctness of the details he submits.

6. DISTRIBUTION OF PRIZE MONEY AND INDEMNITIES

All prize money will be paid by bank transfer/cheque in €/£ as applicable after completion of the last competition of the Championship at the latest.

7. INSURANCES

The Show, the Organisers their respective Officers, Servants or Agents shall have no liability for any injury, loss or damage whatsoever and howsoever caused to or suffered by the Competitors, Exhibitors, Invitees or Spectators, their property, servants, agents, horses or other animals. Each Competitor, Exhibitor and Invitee shall indemnify and save harmless the Organisers in respect of any damage or injury of whatever nature and howsoever occasioned to any person or property by any such Competitor or Exhibitor or any horse or other animal which he or she brings or is responsible for bringing to or upon the premises of the Organisers.

All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.

8. SAFETY CUPS

FEI approved safety cups manufactured by Cardinali and Rothenberg Gmbh.

9. ENTRY RIGHT TO SHOWGROUNDS (Art. 133, 1005)

Accreditation permitting entry to stable area according to FEI Veterinary Regulation Art. 1005.2.5. will be issued as follows:

In addition to the above, the OC will offer three additional accreditations to each participating NF allowing access to the stable area. These will be free of charge but will only be issued on merit. Such passes are intended for use by Chef de Mission, Farrier, Physiotherapist or similar individuals.

Applications for all accreditation listed above must be made by the relevant NF through the Hippobase Entry System.

All competitors, owners, grooms and other relevant persons must display their passes at all times, otherwise entry will be refused.

All horses competing at the event must be stabled on the showground and are not to be removed between the dates of:

Dressage: Monday 24th August and the last competition on Saturday 29th August 2009. **Jumping**: Tuesday 25th August and the last competition on Sunday 30th August 2009.

Riders wishing to leave earlier than the dates specified above who will take no further part in the Championship may do so ONLY with the permission of the Foreign Veterinary Delegate.

All horses will be issued with a bridle number on arrival at the event. This number must be clearly displayed on the horse at all times when it is out of the stable during its stay at the event.

In addition, all competitors (or person responsible) will be issued with one Emergency Contact Stable Card (ECSC) for each horse upon arrival. This card must be completed and attached to the horses stable door. In the event that a horse is found to require treatment and the competitor/person responsible cannot be contacted, the treating veterinarian will treat the horse as he/she sees fit.

The Organisers reserve the right, subject only to the agreement of the Ground Jury, to remove any horse, Owner or servant (person responsible) from the event, or to refuse admission without being liable for compensation.

All participants must check in at the Accreditations Office immediately upon arrival at the showground.

12. START LISTS & RESULTS SHEETS

The name of the owner of each horse will be added to all start / result sheets as well as it's stud book initials, country of birth, sex and age.

13. DISPUTES

In the event of any discussion concerning the interpretation of the schedule (in translated languages), the English version will be decisive.

14. DRESS/HEADGEAR

Competitor's attention is drawn to FEI Article 256.1.4:

It is compulsory for anyone jumping a horse to wear a properly fastened hard hat with three point retention harness, including members of the armed services, police, gendarmerie, members of military establishments and national studs.

This is strongly recommended also for anyone working a horse in the exercise and schooling areas or anywhere on the showground.

15. IMAGE RIGHTS

It is a condition of entry that all competitors and the owners of their horses will permit any photographic or filmed material derived during the course of the event, to be used subsequently by the Organisers for future promotion of their business interests, or the show at no cost to the latter.

16. HEALTH & SAFETY

All participants and visitors to the event must agree to observe and adhere to any and all health and safety policies or instructions issued to them by the organisers of the event. These will be displayed in both the Stable Manager's Office, the Organiser's Office and at all points of entry to the event site.

The following at least will apply:

- i) The organiser has the overall responsibility for Health and Safety.
- ii) The event is organised in accordance with Health and Safety legislation and all who have, to any extent, control of the premises or site at which the event takes place are responsible for ensuring that:
- a) Everything reasonably practical is done to ensure the health, safety and welfare of those attending the event.
- b) They conduct themselves in such a manner so as not to put themselves or anyone else at risk.
- c) Access to and egress from the site is safe.
- Members of the public, competitors and grooms are equally responsible for ensuring that they do not put other persons at risk and that they co-operate with the organisers in compliance with all Health & Safety legislation.
- iii) Emergency Access in the case of an emergency, the emergency services must have unrestricted access to all areas of the event site at all times. To that end, all participants and visitors to the event must ensure that vehicles are only parked in designated areas and at no time obstruct access to any part of the site.
- iv) Horses horses can be easily frightened and can be dangerous. Members of the public will be requested to keep clear of equine areas and to avoid behaviour that might alarm horses, however competitors and grooms are also requested not to take horses into public areas and to remain in the areas (arenas, warm-up areas, horsewalks and stables) designated for equine activity.
- v) Children children, be they accompanied by participants or visitors to the event must be supervised by parents/guardians at all times.

17. EVENT'S ORGANISATION - (Art. 110.2)

In exceptional circumstances, together with the approval of Chefs d'Equipe and Ground Jury the OC reserves the right to modify the schedule in order to clarify any matters or matters arising from an omission or due to unforeseen circumstances.

Any such changes must be notified to all competitors and officials as soon as possible and they must be reported to the Secretary General by the Foreign Judge.

THE FEI CODE OF CONDUCT

FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

- 1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
- 2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
- 3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
- 4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
- 5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

Championship Penalties:

The scores obtained by each competitor will be converted into points by multiplying the time of each competitor by the coefficient 0.50; the score must be rounded up or down to the second decimal place. The second decimal place will be rounded up from .005 and rounded down from .004. The competitor with the lowest number of points after this conversion will be given zero penalties, the other competitors being credited with the number of penalties representing the difference in points between each of them and the leading competitor. If a competitor is eliminated or does not complete his round for any reason, he will be awarded the same number of penalties as that incurred by the competitor who has been the most severely penalised, plus 20 penalties. If the competitor concerned has himself received the highest number of penalties before being eliminated or retiring, 20 penalties will be added to his score. Adding the 20 penalties is done after the time difference has been converted into penalties.

Eligibility - Round 2: The 50 riders (such number to be increased if there is equality for the 50th place) having the best score deriving from the addition of the scores obtained in the First Individual Qualifying Competition and Round 1 of Team Competition (Second Individual Qualification Competition) are allowed to participate in the Third Individual Qualification Competition which is the Round 2 of the Team Competition.

Starting Order:

Individuals – Round 1: First to start in Round 1 of the Team competition are all individuals. The starting order of individual riders in Round 1 of the Team competition is according to the reverse order of individual classification in the first competition. In case of equality of penalties for any place competitors retain the same starting place as in the first competition.

Teams – Round 1: Following the first Individual competition, teams are divided into two groups based on the results of the best three competitors in each team. The first group of teams to start in the first round of the Team competition is that with teams placed eleventh and beyond. The group with teams placed first to tenth and those ex-aequo for tenth place start last. Teams in each group start in the reverse order of classification resulting from the first Individual competition. There is a draw to decide the starting order for teams in case of equality of penalties.

Individuals – Round 2: The starting order of the Individuals qualified to compete in Round 2 is set according to the reverse order of the aggregate penalties incurred in the First and the Second Individual Qualifying Competitions In case of competitors with equality of penalties, the score of the first competition will decide their starting order.

Teams – Round 2: The starting order of the Teams qualified to compete is set according to the reverse order of total penalties of the best three competitors per team incurred in the First Individual Qualifying competition and of the best three competitors per team in the Round 1 of the team competition. Teams with equality of the penalties retain the starting order of Round 1.

Classification - Team Placing

The ten teams and those with equality of penalties for tenth place receive their placing by adding the penalties incurred by the best three competitors in each team in the first competition and the penalties incurred by the three best competitors in each of the two rounds of the second competition. The team, which has obtained the least number of penalties will be placed first and declared Continental Team Champion.

In the event of equality of penalties between teams for first, second and/or third place, there will be a jump-off against the clock in which all team competitors may take part, over six obstacles, which may be increased in height and/or spread at a speed of 375 m per minute. The score in this jump-off is obtained by adding the penalties incurred by the three best competitors in each team, but in the event of further equality of penalties, the times of these three competitors in the jump-off added together will decide the winning team as well as those placed second or third. The score of this jump-off is only to determine the placing of the teams and will not count towards the final scores of the individual competitors.

If two jump-offs are required, the jump-off for the third place shall precede the jump-off for the first and the second place. If after the jump-off there is equality of penalties and time for one of the first three places, the teams concerned will be placed equal. Teams not qualified for the second round of the Team competition receive their placing by adding the penalties incurred by the three best competitors in each team in the first competition and the penalties incurred by the three best competitors in the first round of the team competition.

Competitors must have taken part in the first competition (completed or not) and have completed the second competition (without having been eliminated or having retired) or have taken part in the first competition (completed or not) and have completed the first round of the second competition as well as the round replacing the second round of the team competition for individuals and members of teams not qualified for the second round of the team competition (without having been eliminated or having retired). If for any reason one or more of these 25 best placed competitors are unable to start, they will be replaced by participants from the reserve list of five competitors.

Starting Order:

Round A: The starting order for Round A will follow the reverse order of penalties incurred in the first and second competitions. For those individuals and members of teams not qualified for the second round of the team competition the starting order will follow the reverse order of penalties incurred in the first competition and the first round of the second competition as well as the round replacing the second round of the team competition. In the event of equality of penalties, the score of the first competition will decide the starting order. The 25th qualifier will, therefore, start as number one.

Round B: The starting order for Round B will follow the reverse order of total penalties incurred in Round A of the Final competition, as well as in the first and second competitions. For those individuals and members of teams not qualified for the second round of the team competition the starting order will follow the reverse order of total penalties incurred in Round A of the Final competition, the first competition and the first round of the second competition, as well as the round replacing the second round of the team competition. The competitor with the most penalties will start first, the competitor with the least penalties will start last. In the event of competitors with equality of penalties, the score of the first competition will decide their starting order.

Classification: Individual Placing

The individual placing is determined by adding together for each competitor the penalties incurred in the first competition, as well as the two Rounds of the second competition (disregarding the penalties incurred in the jump-off if there is one) and the two Rounds A and B of the third competition. For those individuals and members of teams not qualified for the second round of the team competition their score in the second round qualifier counts instead of the second round of the team competition.

The competitor with the least penalties will be placed first and declared the Continental Champion.

In the event of equality for one of the first three places after Round B of the third competition, there will be a jump-off against the clock at a speed of 375 m per minute over 8 obstacles from the courses of Rounds A and B. The competitors will be invited to inspect the jump-off course.

If two jump-offs are required, the jump-off for the third place shall precede the jump-off for the first place and the second place.

If after the jump-off there is equality of penalties and time for one of the first three places, competitors concerned will be placed equal.
